Editorial

No more death for profiteering

The senseless rush for business and sales takes another life again at Davangere, Karnataka. A Torrent filed worker, Krishnamurthy V Kulkarni, hanged himself to death. He was working for torrent since last 11 years, Torrent is a giant pharmaceutical company in India and Krishnamurthy remained profitable for the company for all these years. But, now, in one fine morning, Krishnamurthy found his life not worth living and committed suicide.

Again the bare fact is that his devastated wife, instead of shedding tear in isolation, rushed to the police station and lodged complaint against the torrent management. She accused the Torrent management of torturing her husband to death. The testimony of his wife is very important. The tormentation and torture which a field worker passes through does not have many witnesses. But the wives (or husbands) and family members know how a field worker becomes restless, disturbed and upset when desired sales does not come home. Then home becomes hell. Krishnamurthy's wife knew how a healthy and joyful individual got unsettled, distressed, and sorrowful and then took the extreme step.

How come the call of death overwhelms the call of life and how a situation induces a person to kill himself is a matter of enquiry of the sociologists. A psychologist or a psychiatrist will search for a reason from yet different angles. But the co-workers and the family members know the truth for certain. The immense demand for sales performance, threat, humiliation, abuse, maltreatment meted as a routine over a long period of time and linking of sales performance with severe unjust punishments like job-loss, transfer, wage cut, freezing of increment, withholding of wages creates a maddening situation for a field worker, especially who is isolated, forlorn and unorganized in the fierce jungle of a roaring pharmaceutical industry.

27-year-old Ashish Awasthi committed suicide in Indore, Madhya Pradesh in 2018. This time it is 34 year old Krishnamurthy V Kulkarni. These two filed workers and many other in the mean time and before. committed suicide as they could not meet the sales demand of their employers and moreover, the bare fact was that such demands were irrational but it was linked to the service condition and the ultimate punishment. The violence of sales target takes its toll again and again. Should a 'popular', 'democratic' government not address the issues of the field workers, if such government is truly popular and truthfully democratic? Should sensible and responsible central government not use executive power or enact law to protect the valuable lives of the young field workers? The present government which is busy pleasing the wealthy elites does not have much time to look in to the distress of the field workers; neither has it any intention to do so.

But, ensuring justice is possible and necessary. Untimely and unceremonious death of scores of field workers is not without remedy. There exists enough reason for government to intervene and the stop the employers from unleashing incessant torture. It can be done both through executive power and through enactment of law or through use of both.

Field workers' movement demanded of framing of statutory working rules in this perspective only. Statutory working rules has to framed keeping in view the distress of the field workers and not for issuing free license to employers for robbing or killing the field workers. But this government is not ready to hear the voices of the people therefore they have concocted a retrograde and regressive 'draft of statutory working rules' in violation of labour rights and in contravention to the recommendation of the tripartite industrial committee.

Field workers should get relief and respite from torture that is inherent in the private working rules composed by the individual employers in 'go as you like' manner. Such private working rules links sales with service and working conditions and enables employers to take extreme action and cruel punishment against the field workers and help them to impose unbearable workload and irrational work system upon the field workers. In absence of lawful working rules and in absence of job specification, job responsibility and hour of work and with the advent of internet, electronic devices, web-based apps and surveillance, further burden has been mounted upon the field workers and sum total of all these has made their condition further worse.

In this background only FMRAI has demanded reframing of statutory working rules. Should such statutory working rules that protect the workers not come into existence right away? If not, then, how many deaths field workers have to die before this government is able to frame this, appropriately? If this government is profoundly deaf then field workers' movement, coming down to the streets in large number, stand firmly hand in hand with the masses and will find out its own answer.

It is time for field works movement to cry foul against unremitting onslaught. Field workers have paid and are still paying very expensively for their livelihood. Now, enough is enough! No more death to die. If a people's government is so impaired of hearing then the people must tell this government to go. At least, field workers' movement will wish that

General strike

The members and cadres of FMRAI took to the streets in large number in all parts of the country on both the days and organized the strike shoulder to shoulder with other central trade unions and federations. Field workers along with other trade unions and federations and the like-minded organization took out procession, organized demonstrations, squads, public meeting and picketing in more than 400 cities and town with banners, flags, demand posters festoons, displaying the demands of the strike. More than 2 lakhs field workers, irrespective of their level of unionization, abstained from joining their work and therefore, all marketing activities came to complete shutdown during the 48 hours of strike.

By organizing picketing field workers enviously guarded their places of work, defied the threat of the management of the companies. In some places there have been repression by the and the central governmentwho used the power of the authorities to defeat the strike and to disband the unity of the striking workers. In some places police picked up and detained the leading comrades of the subunits and state units of FMRAI. Yet in some other instances FMRAI members have been rounded up by some groups of thugs and physically assaulted. In spite of all these, FMRAI members did not leave the spot and made the strike a striking success.

all the Besides common demands of the working class, the striking field workers also upheld the medicine related demands of the people and the labour related demands of the field workers. No GST on medicines and medical devices. making stringent law with punitive clauses to end to unethical marketing andtrading and to scrap the draft statutory rule, working that fundamentally anti-worker, and reframe the same in line with the recommendations of the tripartite industrial committee.

In Maharashtra General Strike was observed by field workers beyond the membership of MSMRA and throughout the statepicketing dharna and other programmes were organized. Independent rally was conducted Nagpur Nashik, Motorcycle rally and submission of memorandum to collector was organized at Wardha, demonstration in front of district collector and memorandum submission was organized at Bhandara. Rally and Memorandum submission was organized at Yavatmal, Beed andSatara. Memorandum was submited to Tahasildar at Karad after a huge procession.In Malegaon .Shrirampur. Baramati and Sangamner, Ratnagiri memorandum was submitted to government authorities. Our members also participated in Rasta Roko, joint rallies and other programmes along with other trade unions. On 9th January 2019, MSMRA organised demonstration in front of the Commissioner of Labour (Government of Maharashtra) BKC Mumbai. Large number of striking field workers arrived at the of demonstration. Memorandum implementation of SPE Act in Maharashtra-based companies, review and upward revision of Minimum Wages, notification for implementing 8 hour-work, removal of ceiling on **ESIS** benefit, review. implementation and enforcement of Bonus Act (as amended), enforcement of implementation of ID Act by forming grievance redressal forum, was submitted to the commissioner of labour. A delegation of leadership explained the demands once again to the labour authorities.

In Gujarat more than three thousand field workers joined strike. GSMRA members picketing organized Ahmedabad, Bhavnagar, Jamnagar, Valsad. Nadiad, Navsari, Mehsana, Bhuj, Himmatnagar ,Patan, Rajkot, Amreli and other cities. Because of organized picketing and through support of USV field workers USV management failed to hold sales promotion meeting at Ahmedabad during strike. At Vadodara Bhavnagarmembers participated in the rally organized by CITU. GSMRA members at Junagadh participated in Dharna for two days organized by CITU.

Members of the state council and sub unit left no stone unturned to extend their hands of cooperation. He joined Emcure in the year 2000 and served our organisation actively as a joint convener of the state council and as local committee member at Agarpara LC in North 24 Parganas district. He has left behind his old mother, wife, a son and a daughter. FMRAI deeply condole for this untimely death and express deepest condolences for his bereaved family members.

FMRAI rejects management's justification

Closure and transfer in Cadila division of Zydus at Kolkata

Zydus Health Care, a giant pharmaceutical company in India has closed down marketing operations of Cadila division at Kolkata and other headquarters on the ground of viability of the territories. Through an arbitrary instruction, services of the field workers who are based at Kolkata since long have been transferred to different places including distant places.

In this letter dated 1st February 2019 the management has reasoned such closure upon stringent competition, newer regulatory measures, price control, etc. Since government policies are bad to the company, then only, the company has shifted such bad thing upon the field workers and then only, asked the field workers to bear the brunt. Finally they zeroed in on the sales performance, making field workers of Kolkata responsible for unfulfilled sales outcome.

But it has been proved over and over again that Sales outcome is incidental to many factors, including management's input and the market condition. Sales cannot be the exclusive responsibility of the field workers, neither the government policies are framed by them. Therefore, the argument of viability that has been put forward by the management, does not hold water.

Here, in this context, there are specific reasons too. These reasons include shifting of fast moving products like Aten, Ocid from the division to other divisions, lack of continuous managerial support, irrational de-pooling of Kolkata city since 2016, infiltration of goods due to differential credit policy offered to the stockist, insufficient promotional materials etc. In close examination, it reveals that the closure of marketing operation of Cadila division at Kolkata is completely unjust and unlawful.

FMRAI has rejected the contention of the letter and has written back to the management, dismissed management's arguments and demanded immediate resumption of marketing operation at Kolkata and revocation of all transfers back to their respective territories at Kolkata and other places.

barbaric torture of the Torrent management on the sales ground.

With amazing spontaneity Torrent field workers across divisions designationexpressed their anger. On 24th Jan, the company arranged 'Founder's day web cast program' in many places. The management postponed the program in West Bengal (Kolkata) Telangana (Hyderabad) and Kerala. In some places the shameless management of Torrent asked the field workers to remove the condolence Black ribbon from their chest which field workers' refused to do. On account of this incidence the scheduled programme of the company could not be held at Patna, Siliguri, Bardhaman, Midnapur and Aurangabad. Field workers stood en masse outside the venue which brought further shame to the company. The field workers wore black badges in all other parts of the country as well. Central conference of CRU held at Dibrugarh and IND



The 23rdCentral conference of CRU (NER) held at Dibrugarh, Assam on 4th and 5th January, was attended by 189 delegates from 16 organizational districts of CRU representing seven administrative states (Assam, Tripura, Meghalaya, Arunachal Pradesh, Manipur, Mizoram and Nagaland) of the country. A colourful mass rally, with large participation of other fraternal and like-minded trade unions and organizations, was organized in Dibrugarh town on the occasion of this conference which started from the venue following hoisting of the flags of CRU and CITU and ended in the venue after traveling through the streets of the town. Around one thousand member of CRU joined this rally and the open session.

Wage settlement between WBMSRU

On 2 December, 2018 the 8th consecutive wage settlement between IND and WBMSRU was signed. IND is a small scale sector pharmaceutical company of West Bengal, maintaining bilateral relation with WBMSRU for over two decades. The settlement is effective for three years from April 1, 2018. On account of revision in wage and allowances, there will be an average benefit of Rs.2250/- per month for each sales promotion employee. On behalf of the management, Mr. Malay Roy Choudhury-Managing Director, Mr. Kashinath Deb-Sr. Sales Officer and on behalf of unionSisirSaha, President andBasabRoychowdhury, Secretary of WBMSRU along with the council leadership signed the settlement.

New membership portal of FMRAI

Membership beyond one lakh is not the glory of number alone even though number alone, and number as such is also extremely important in trade union movement or in any democracy. Be it democratic institution or be democratic exercise, the number counts and also decides the outcome. This number actually speaks of undiminished attractiveness of the organization of the field workers even in adverse and inhospitable circumstances. It is an important source of the strength of the field workers in the country.

But this strengthand force has to be employed in heightening and expanding the movement and for that purpose various data in relation to individual members is required. faster for communication from movemental center and for scores of other reasons. Sometimes, in the hearth of a movement, it is required urgently

immediately. Membership portal of FMRAI has been envisaged, designed and then launched, for this purpose only.

This portal will enable the organization to store brief and relevant records of the members and also allow organization to get access to it very quickly. We hope to leave behind those days when we could access with consumption of much time, some incomplete information regarding our members. Now this uniform membership register will keep records of the members across state units and will be accessed and maintained by the state units and FMRAI centre.lt will also enable All India councils and the subunits to get quick information about renewal, non-renewal and new enrollment of the members. It will also be useful in relation legal matters.

In short the new Membership portal of FMRAI that has already been sent in motion is a step forward towards the future.

Delhi High Court Bans on line Sale of Medicines

In December, 2018, a bench of Chief Justice Sri R.Menon and Justice Sri V.K.Rao passed an order banning on line sale of medicines through epharmacy throughout the country and directed the central and Delhi government to implement it immediately.

A PIL was files by a Delhi based dermatologist, Dr. Z.Ahmed, complaining that medicines are exclusively sold through on line almost without any regulatory checks and resulting huge risks to the patients consuming the medicines and also inter alia affecting the doctors the worse. In January, 2019

hearing the Delhi High court maintained its earlier stand. Next hearing is in February, 2019.

Online sales of medicines and e pharmacy going on unabated by violating exiting drug laws of the country. Online pharmacy immensely increases the possibility that substandard drugs, spurious drugs, fake drug or unintended drugs reaching directly to the ailing people, the consumers without any check and control. Thus, the online supply of medicines has serious repercussion for public health. In this context, FMRAI is opposed to online sales of
