settlement between 6^t wage management of TTK healthcare limited and negotiating committee representing FMRAI was signed on 2nd August, 2019 at Chennai. Management was represented by Mr. D J Parthasarthy, Senior VP-& Marketing , N wasan VP-Sales Sales Mr. Keerthivasan, VP-Sales & Marketing, Mr. S.Balakrishnan, Marketing, Mr. S.Balakrisnnan, DGM, Marketing services, Mr. K V Mujumdar, DGM-HR, Mr.M

Murugan, Senior DGM-HR, while the negotiating committee was represented by Avijit Bose, Rajeeva S Pandey, V B Pathak, K Bose V Ajith Kumar, Sanjay Kumar and J Rengarajan. The wage settlement covers a period of three years, between 1st January, 2018 and 31st December, 2020. The total benefit ranges from the minimum of Rs.2335 in the first grade to the maximum of Rs.5216 pm in the fourth grade. There have been upward revision in the pay scale through increase of Rs. 1000 in entry point of the pay scale and through increse in the rate of increment. Benefits accrued of grade change increased. VDA have also increased by Rs.0.20 per point, from existing neutralization rate of Rs. 1.45 to revised rate of Rs.1.65 per point of rise or fall of AICPI. FDA increased by Rs. 150, Rs.175, Rs.200 and Rs.225 in four respective grades. House rent allowance, Education allowance, Kit allowance, Vehicle maintenance allowance Leave travel assistant and assistance also increased in this settlement. Metro city allowance at the rate of Rs.2000 per month has introduced as a new element in this settlement. Bonus will be paid at the rate of 20 percent. Through this settlement 287 field workers in three division namely, Endura, Excella and Gynova

division, will be benefitted.

For protection from unspeakable horror

Editorial

In the deep of forest, there prevails the law of nature and the rule of the jungle. There the stronger ones hunt the weaker In the modern democratic societies, the laws of nature are attuned to the human values and therefore, laws and rules are made by man. Here, weaker ones are protected through promulgation of law and stronger ones are restrained by law, by enforcement of law.

Protect SPE Act' read the badges that thousands of field workers wore in the month of August. In this August of Independence Day fervour field workers signed memorandum that raises a primary demand: Protect SPE Act. Through this field workers got down to fight the rule of the jungle, which the senseless access of neoliberal restructuring has created in India.

A large number of workers from different industries and establishments, along with the field workers, who voted the National Democratic Alliance government to power at centre for the 2nd term, expected that the new government will give some protection to the weak and the vulnerable. It was hoped that the workers, who too are no less vulnerable today, will also get some protection. But this hope and expectation has been belied when the government has attempted to repeal specific acts and has introduced two codes mixing, rewriting and thereby, jumbling up all these acts together. Instead of restraining the strong, instead of checking hostile employers, the government made the workers a soft target. This action of the new government has added to the woes of the workers.

Wage Code is passed from both the houses and notified by gazette, while the Occupational Safety, Health and Working Conditions Code, 2019 Conditions Code, 2019 (OSHWC) bill has been introduced in Lok Sabha on 23rd July. This OSHWC bill attempts to repeal the only specific and particular act for the field workers. Now, a defender of the Now, a defender of the government position will definitely ask a question: was it really necessary to have separate act for the sales promotion employees? Is it really necessary today especially when there is a talk and attempt for 'one country, one culture, one language, one religion, one law, one party, one leader'? Are not separate laws for particular sections of workers guite unsuitable, or even improper, for our nationhood?

The answer to all these questions is in the not, as such questions denies the atrocities that the field workers faces days in, days out. These questions, in fact, constitute nothing but hollow nationalism. In the main body of the act itself, in the 'Statement of Objects and **Reasons'** in the very introduction of the SPE Act, 1976, states, 'keeping in view the justification of the demand of the sales promotion employees, and the recommendation made by the Committee on Petitions, and taking other relevant aspect into consideration, it is considered more appropriate to have a separate legislation for governing the conditions of service of sales promotion employees...'. The act itself, describes the perspective of the promulgation of the act. This part of the act makes it clear that on the basis of 'a petition made by the Federation of Medical Representatives' Associations India, the Committee on Petitions (Rajya Sabha) in its thirteenth report submitted on March 14,1972, came to the conclusion that "the ends of social justice to this class of people will be met only by suitably amending the definition of the term 'workman' in the Industrial Disputes Act, 1947 in a manner that the medical representatives are also covered by the definition of 'workman' in the said Act". The Committee also felt that other workers engaged in sales promotion should similarly be considered as workmen.'

True to the spirit of an act promulgated in a democratic country this part of the act admits that 'as such' the field workers 'have no protection regarding security of employment'. Thus when the question of 'nationalism' was not just a matter of preaching but that of a practice, then the specific need of 'protection' of a particular section of workers was recognized. At that time some nationalist ideas of those days made ways for a specific new law for the field workers.

Now, it is different. Government

instinct of the economy is unleashed. This is neoliberal economy studded with policy of taxing the poor (through indirect taxes like GST), withdrawal of subsidy for the poor, giving subsidy and concession instead to the big business, ease of big business and withdrawal of assurance of life and livelihood of the common people. This equal economy is to unemployment, retrenchment,

wage freeze and price rise. The government plans to manage the new economy by recklessly attracting more and more investment. Government attempts to lure the investors at any cost. investors demands of destruction of the public sector. Government does it. Government sells out the properties of public sector to the private investors at throw away prices. These investors further demand of 'labour reforms'. Government says, 'Yes sir, come and invest, we are quickly marginalizing our labour!'

In the name of labour reform Government attempts to repeal SPE act though some contents of this repealed act, however, find place in the reconstituted mixture of OSHWC code bill (13 acts mixed). Through this field workers are threatened to lose protections which they got through SPE Act. Besides, a good number of were covered and benefits of which they have availed through SPE act in all these years, are set to be withdrawn.

The OSH & WC Code does not, either explicitly or implicitly, guarantees or mentions, that the field workers will continue to get the coverage of Industrial Disputes Act, 1947, Compensation Act, 1947, Workmen's Compensation Act, 1923, Maternity Benefit Act, 1961, Payment of Gratuity Act, 1972. In fact, through OSH & WC Code, field workers lose the applicability of Workmen's these acts.

The OSH & WC Code continues the benefit of earned leave and sick leave but does neither guarantee nor mention that the existing benefits like casual leave (15 days), quarantine leave (30 days), study leave and compensatory holidays will be continued. That the field workers will be issued appointment letter is not mentioned in the new code, neither does it prescribe a form or format for issuance of appointment letter. There is also no mention, in the codes, of any register for SPEs or a service book for them, as

mentioned in the rules under the SPE act.

It is believed that rules under this code will be framed and some of the elements mentioned above may or may not find place there. However, some new rules under the SPE act (or for that matter the rules under the impending the OSH & WC Code) is already a contentious issue for the field workers, especially in relation to statutory working rules. FMRAI has already rejected the draft of statutory working rules which has been prepared by the NDA government in the previous term without recognizing the need of giving protection to the field workers (in the context of imposition of anarchic and arbitrary private working rules by departure from the recommendation of the tripartite committee and only at the dictates

of the lobbying employers. In both the Wage code and the OSH & WC Code the terms like 'workers', 'employees', 'industry' ,'sales promotion' are either not well defined or loosely defined or they are ambiguously employed in the main text keeping room for confusion, doubt, vagueness and thereby throwing open the scope for unseemly or even unscrupulous interpretations. This creates uncertainty in applicability of the codes for the field workers

Thus, the Wage code, through which the Minimum Wages Act, 1948 and the Payment of Bonus Act, 1965 has been repealed, reconstituted and mixed , somewhat ambiguously mentions Sales promotion employees' for coverage of field workers under the code.

Through wage code Government attempts declaration of some pittance called National Floor Level Wage. The government proudly asks the state government that the minimum wage declared by the state should not be below the National Floor Level Wage. In fact, the new formula of the central for arriving at the quantum of minimum wage makes minimum wage piteously low and in fact, no state government will remain prepared to be shamed by the keeping the minimum wage lower than the National Floor Level Wage. They will neither be able to keep it much above the National Floor Level Wage as they may fear that the investors will run away and go to other states where such wages are

class through labour law 'reforms' has to be challenged through nationwide agitation agitation and propaganda. close to National Floor Level Wage. Thus, the wage code attempts to impoverish the workers who are already impoverished enough. Through all these codes this nationalist Government permanently impose upon the workers 'a system designed to maintain the inferiority of their lives

'Unspeakable horror' of employers' brutality is nothing new, either in India or in the sales promotion industry. What is new is the withering of the already-thin veil of the welfare state. The introduced codes (and some more upcoming codes) attempt to make the weaker further weak and the stronger further strong. It attempts to perpetuate the brutality of the employers.

What kind of nationalism is this that surrenders to neoliberal plunder? In fact, it is a nationalism that has been unsuitably married off to the neoliberalism. In this ghastly marriage 'labour reform' is the dowry that is being given to the neoliberalism. For this neoliberalism. this dowry unreasonable the workers are made to pay. For this unscrupulous marriage workers

are made to suffer the most. The NDA government is doing things most arrogantly, more aggressively, more shamelessly than any other previous governments in independent India. The people who voted this Government to power need to take a break and ponder over the new realities. There is no reality that will drop from the sky. There is no reality for the workers beyond their lives, their livelihoods and their rights. Now, we have to decide. Now, we have to choose. We have to choose between silence and eloquence. In the language of Martin Luther king Jr., it is the time when 'silence is betrayal'.

FMRAI is well aware about it. Therefore, following the betrayal of July (OSH & WC Code) field workers take to the streets across the country in the month of August. This August too August too celebrated Independence Day with great passion. With a view to defend the freedom of life and livelihood field workers cried foul in this August only and demanded justifiable protection in the hell of labour reform. Now, it is time for further eloquence and at this hour mass of field

workers must be introduced to the truth. The truth lies in the struggle and there alone lies the pass for a dignified life.

Protest day against Change of Labour Laws
