### All India Council Subcommittee meeting plans the future tasks



The All India Council Subcommittee meeting was held on 15th December, 2019 at Kolkata. The meeting was planned to review the activity carried out during the period and to decide the future united movements to face the present situation of increasing attacks on council movement. The meeting was attended AICSC members and state council subcommittee conveners. Ramesh Sundar, President, FMRAI, presided over the meeting.

The meeting was participated by 29 All India Conveners, 14 Joint All India with Conveners representation from 10 State council subcommittees. General Secretaries of three state units of FMRAI were also present in the meeting. Most of the All India councils were represented in the meeting. On present situation in relation to trade union rights, recognition of FMRAI and attacks on organization, a note on behalf of the core committee of All India

Council Subcommittee was placed by Pranab kr. Ray, Convener, All India Council Subcommittee.

He emphasized upon the importance of collective movement in resisting the current onslaught, especially when the Central Government is trying to make all labour laws more flexible in favour of the corporate. More vigorous movements has to be built against the employers who consistently violating the existing labour laws and adopting all sorts of unfair labour practices. The meeting reviewed implementation status of the task taken in All India Council Subcommittee meeting held on 4th August, 2019 at Nagpur and noted the suggestions for future of movemental programmes in the area of concerns of Council Movement.

It has been observed that many improvements have taken place in the area of implementation of the programmes by majority of

The government admitted in Lok Sabha on 9th December. 2019, that 'prices of 20 of 22 key food items rose steadily in Union minister. responding to a question in the House attributed such increase to shortfall in production, increased transportation costs. lack of storage facilities and artificial shortage created by hoarding and black marketing'(Times of India, 11th December, 2019). Prices of most of the items listed under the Essential Commodities Act, 1955 (ECA) are increasing relentlessly. Prices of fertilizer, rice, pulses, wheat, sugar, molasses, milk, meat, fish, potato, onion, edible oils, fruits, vegetables increased very sharply during the year. Prices of petroleum and petroleum products increased by Rs 6 or Rs 7 across the country between 30th December, 2018 and 30th December, 2019. As the prices of cattle fodder increased, so increased the milk prices. Prices of the fertilizers increased impacting the cost of production of the crops, including food crops. Onion price increase kept no bounds. It is not intelligible how 26% reduction in onion production in one harvesting season, has triggered 400% increase in onion prices (in some places retail price increased to the tune of 1000% or 10 times in just 4-5 months). While all these essential commodities are covered under the Essential Commodities Act and the dominant object of the act is to secure adequate production, distribution and availability of essential commodities at fair prices 'in the interest of the general public', the government did little (except declaring stock holding limit on onion) to invoke the act in appropriate manner thereby allowing hoarding and speculative trading in large number of essential commodities and food.

Increase in food prices is extremely upsetting as it is very closely related to hunger and malnutrition. The study report published in The Lancet (issue December, 2019, Vol 3, titled, 'The burden of child and maternal malnutrition and trends in its indicators in the states of India') found that 'malnutrition was the predominant risk factor for death in children younger than 5 years of age in every state of India in 2017, accounting for 68.2% ... of the total under-5 deaths, and the leading risk factor for health loss for all ages...'. The study underscores that also malnutrition is also a major cause of overall disease burden, loss of life years due to ill-health, disability and major cause of early death. The study also found that the prevalence of low birth-weight in India in 2017 was 21.4%, Child Stunting Editorial

### The winter of protest and resistance

39.3% (low height for age), Child Wasting 15.7% (low weight for height), Child Underweight 32.7%, Anaemia in children 59.7%, Anaemia in women 15–49 years of age 54.4%.

But, even the low food prices are no quarantee for food, if the population is bereft of basic Unemployment, diminishing and wage unavailability of universal basic income deprives the population of food and nutrition. Good crop or affordable price alone does not prevent hunger. The Famine Inquiry Commission Report on Bengal constituted by British rulers in 1944 and prepared by their officials after Bengal Famine during 1943-44, observed that: 'even in normal times, however, considerable numbers among the poorer classes live on the margin of subsistence, because they do not grow enough food and do not earn enough money to buy the amount of food they need. Food shortage in this sense may, and does, exist even when crops are good and prices low and stocks are abundant, and are exported. It is the result, not of a shortage in the total supply of food, but lack of purchasing power in the hands of the poorer classes, that is, of their poverty'. It is unfortunate that the observations made after an infamous famine under British rule surprisingly fits to the current time in independent India.

In absence of universal basic income and in the face of declining purchasing power, the common citizens cannot buy even the essential commodities including medicines. In such a context, any increase in medicine prices hurts the citizens. But the government has hiked the ceiling price of 12 essential drugs (involving 21 scheduled drug formulations) by 50 per cent which was notified by the National Pharmaceutical Pricing Authority (NPPA) on 13th December, 2019. These medicines are BCG vaccine, Benzathine Benzylpenicillin, Choloroquine, Dapsone. Furosemide, Metronidazole, Ascorbic Acid, Co-trimoxazole, Pheniramine, Prednisolone and Clofazamine.

According to Livemint the manufacturers sought to discontinue the production of these medicines on the ground of high cost of production and therefore Standing Committee on Affordable Medicines and Health Products (SCAMHP) under Niti Aayog has recommended a onetime price increase to the extent of 50% for these 12 medicines. NPPA reportedly noted in its meeting that 'while ensuring affordability, access cannot be jeopardized and the life-saving essential drugs must remain available to the general public at all times'.

. There is no doubt that these medicines like BCG Vaccines(TB vaccines), Chlroquine (antimalarial), Dapsone or Clofazamine (both are antileprosy), metronidazole(antibacterial, anti-amoebic), are essential medicines and are of great importance in view disease pattern prevalent in our country.

The fact remains that large number of bulk drugs and penultimate are imported from China (out of all imported bulk drugs and intermediates, 68% comes from China) and other sources even if India has as enough of production capability and technology, as to 'make in India' all these medicines (active pharmaceutical ingredient, API). Spree of senseless liberalization including import liberalization, creation of level-paying field for the multinational drug manufacturers, willful destruction of enormouslysized and world-famous public sector drug companies like IDPL and HAL, government-sponsored discouragement to the indigenous bulk drug manufacturers in private sector has damaged and continue to damage indigenous production of bulk drugs and further compromising self-reliance of the country in bulk drug production making the country's common people dependent on bulk drugs imported from foreign land.

In the present instance imports have been costlier following certain regulatory issues in China, from where it is imported. This situation has led to increase in manufacturing costs and reduces return on investment. But drug companies are not interested to put people over profit. No matter how desperately a leprosy patient needs Dapsone or Clofazamine, it will not be produced (its formulation) unless it is sufficiently profitable. It is not difficult to imagine that the NPPA has been caught in a paradoxical situation and the government and its bureaucrats now have contradicted its own faulty argument that they had advocated for introducing the market-based pricing policy (as against costbased pricing policy) during notification of DPCO 2013. Now, they justify the upward revision of ceiling prices on the basis of cost of production. This vindicates the argument of FMRAI and other organizations that all along are demanding restoration of production-cost-based price control on medicines

Price rise of essential commodities and hike in medicines prices is making life further difficult for common man. But there are several other burning issues too. The different sections of organized workers are already in the streets, organizing protests and preparing for further resistance. 8th January strike kick-starts a new phage of

working class struggle. Farmers and agricultural labourers are no longer ready to suffer in silence and they are pouring down to the streets of the state capitals and district headquarters with resolve in their faces. Women organizations and working women (remarkably the Anganwadi workers) are organizing militant mobilization in search of dignity, self-respect and livelihood. When education is being reduced to a commodity for business and profit, students are fighting a just battle for their right to education. Large scale unemployment has made the students and youths extremely aggrieved and indignant.

But students and youth of this country, especially the students from higher educational institutions, has made this winter a winter of protest. Students from at least 50 reputed universities across the major cities in the country, came down to streets with the copies of Indian constitution in their hands. They raised slogan for freedom from casteism, feudalism, communalism and patriarchy. This time they are indignant not for having been denied of any of their own demands but for upholding the letters and spirit of the constitution. They take to street for safeguarding the very democratic, secular principles of the country.

The ruling dispensation and a section of electronic media had showed the students in bad light even long before these protests broke out. Now during these spontaneous protests by the students, the vilification campaign has further increased. But, the protest actions by the students have earned backing of the peace loving citizens of the country and received solidarity from across the globe. Working class comes to stand by the students' protest, so does the field workers' movement. The common people, the intellectuals, the professionals across religion, culture, language and ethnicity are joining with students and the protest is spreading to newer and news cities and towns of the country and becoming larger and larger.

The working class and the field workers movement is not unmindful that the unity of the people is being challenged in the name religious identity. Hate campaign, with planned employment of the mainstream media and social media, is being organized by the ruling elites to mask the distress of the people in neoliberal days. This organized hate campaign targets a section of poor citizens on the basis of their religious faith and falsely discredit, defame or dishonor them. These targeted sections of people are now being portrayed as monstrous 'enemy of the people'. This hateful propaganda and rabidly communal discourse combined with fake

news is vitiating the atmosphere of the country. The age-old amity among the people is being damaged and unity of the oppressed masses is being seriously undermined.

Now, when the students have come out of their reading room to read the dimmed faces of their fellow citizens, these communal discourses and hate campaign are being materially challenged. Now the time has come when the fight against neoliberalism, against corporate plunder, against theft of labour, against government-sponsored attack on employment, wages and livelihood, against attack on self-reliance of the country, against attacks on rights and liberties should go hand in hand with the struggle against attacks on constitution, democracy and secularism. Those who contemplated (with utter pessimism) that defeat of humanity is irremediable and endless now should feel guilty of their loss of faith. Now the mobilization of the students, youth and the common people proves beyond doubt that the words, like 'democracy', 'secularism', 'unity in diversity', are not lifeless nouns or empty phrases but are living ideals and values. The year ends. The biting

winter will not corner the poor people forever. The protest that has started in this winter will keep lasting influence in casting the future of India. Further course of events may unfold that will prove that no number of bullets and no amount of blood spilled over to the streets, can deter these amazing young men and women from calling a spade a spade. The season of protest and resistance is not over yet. Brutal police force cannot maim protests which are both peaceful and powerful. The arrogance of the ruling classes is no longer the signs of their strength, but of their desperation and fear. Each authoritarian step and each instance of dictatorial hostility only snap the thin veil of their brand of nationalism that is both aggrandizing and hateful. Such state sponsored violence further exposes them to their

One can see, without any great degree of insight that a new India is budding. A new India is tempering itself into steel in the face of lathi-charge, tear gas, arrests and false litigations. With large participation of workers, peasants, students and youth a new India is taking birth in the streets of Delhi, Aligarh, Lucknow, Mumbai, Pune, Chennai, Bangalore, Hyderabad, Trivandrum, Patna, Guwahati, Kolkata against corporate mechanization, falsehood, hate campaign and divisive politics.

It is the might of the people that can and that will, decide the future of this nation. It is the might of the people that creates epic and triumphs over darkness. Field workers too, will claim their share of glory by joining these struggles.

In pursuance of the demand to Sales Promotion Employees (Conditions of Service) Act and oppose OSH & WC Code, the state units of FMRAI including FMRAI secretariat members continued to meet the members of the Parliamentary Standing Committee. The Chairman of the Parliamentary Standing Committee Shri Bharatruhari Mahatab was met twice on 7 and 14 November 2019 by OSRU state unit and the leader of the opposition of Lokshabha Shri Adhir Ranjan Chowdhury was met in a deputation by the Baharampur sub unit of WBMSRU on 14 November, 2019. Apart from these deputations, a delegation team from Bareilly sub unit of UPMSRA

met Shri Santosh Gangwar, Central Labour Minister on 8 December, 2019 at his residence and handed over the demands in black and white. The delegation team discussed about the changes in labour laws, particularly the SPE Act and its adverse impact on the sales promotion employees. #### CITU condemns CAB

CITU condemns RSS-led BJP's Modi government for getting the discriminatory Citizens' Amendment Bill (CAB) hurriedly passed by the Parliament and converting it as an Act after immediate Presidential assent. This is the blackest act in the country's legislative history.

It is an attack on the secular, democratic and equality based inclusive foundation of the Constitutions of India; an assault on the humanity perpetrated by the communal forces guided by fascistic ideology to change the basic character of India's

Constitution towards 'Hindu Rashtra'.

The working class, who are already battling against the aggressive neoliberal policy regime; must rise to the occasion and defeat the BJP government's machination to divide the people and suppress their movement against economic and social exploitation and repression.

Despite CAB becoming a law its implementation can be defeated by the people through united struggle at every stage and in every front. People are already on the street in different parts of

the country opposing the CAB and the Act. Trade union movement must take the lead. CITU calls upon the workers and united trade union movement in general and CITU units and the unions in particular to unitedly launch countrywide movement to defeat of implementation BJP government's Citizenship Amendment Act; and join all other sections of the toiling masses in the countrywide democratic movement against it.
