Following the October Revolution, Vladimir Lenin made it an official holiday in the Soviet Union, but it was a working day until 1965 and thereafter it was declared a non-working day in the USSR. ### **Editorial** The life, the virus and severe acute livelihood destruction

The corona virus disease 2019 is now being counted in millions and death in thousands worldwide. One could hardly foresee such damage and suffering even wildest dream (or in nightmare, as one may say). One shudders to look at the death statistics which are coming in from USA, Italy, Spain, France, Belgium, Sweden, England and Canada where healthcare services are hitherto considered robust and exemplary. Even during lockdown period people in India are infected in thousands and there have been death in hundreds. News coming in that the infected people in some places is denied admission in some hospital. Yet shocking are some instances where the dead men and women are being denied entry in the cremation grounds or burials. 'It is impossible to read the statistics without a silent tear stealing down our cheeks' (Girish Chunder Ghose, on Malaria epidemic in 1863).

Few lakhs migrant workers are stuck by the roadside, on of account sudden shutdown. Central government asks the state governments to provide ration them (bare necessities), cooked food and shelter. According to Stranded Workers' Action Network (published in The Hindu) 100% of migrant workers in UP, 99% of them in Maharashtra, 93% of the in Karnataka are not getting rations. 80% of them in Karnataka, 64% of them in UP, 58% of them in Maharashtra, and 66% of them in Delhi and Haryana are not getting cooked meals. The survey also states that 70% of them do not have more than Rs. 200 in their pockets to fend of themselves. The situation is desperate and some of these workers made frantic move to set out on foot and some of them walked very long distances to reach their homes at native land. Many of them slept on the street. In one instance a group of workers took small fishing boat from Chennai and sailed perilously around 1000 kilometers through Bay of Bengal to reach their homes at Andhra Pradesh and Odisha. Rich people travelled back to their home without much trouble. Students too managed to come back. In a nice instance, during lockdown

only, special buses were arranged for hundreds of pilgrims and they were brought back home to their homes. But, by the order of the governments poor workers were stopped by the police. The employers too denied their wage. Caught in unfamiliar places many of them faces starvation. Away in their homes their family members and children too are in anxiety and hunger. Not only migrant worker, but also daily wage labourers. During lockdown there are no odd jobs. Daily labourers are booed away in fear of disease both in urban and rural areas. Now, MNREGA works too are not there. The Finance Minister (FM) in her relief package for workers declared increase in daily wage of MNREGA workers from Rs. 182 to Rs. 202 which counts as Rs. 2000 (Rs.20 multiplied by 100days) of increase in income of **MNREGA** workers. This increase in actually notional when most of the states are paying wage at a rate higher than that was declared by the FM..

Field workers, like other section of workers, are in the midst of uncertainty and hazard. Some employers ask them to go to the field and threaten wage cut ignoring the government's advisory. Such senseless and wicked acts in the time world-wide pandemic disease generate large scale spontaneous contempt and condemnation from all section of field workers. FMRAI and also its state units are contesting such evil acts of the employers.

Some companies advise field workers to work from home. But mainstay of sales promotion is field work consisting of reciprocation and interaction. It cannot be performed from home. All internet based communications (like e detailing or video calling) is deficient and bizarre enough and therefore unqualified as replacement. It is admirable that some employers are concerned about the safety of the field workers. But such concern should not make an excuse for imposing any new service or working condition on the field workers.

The virus has robbed people of their livelihood too. Indian economy has been in the doldrums since demonetization. Then, this calamity was seconded by hasty introduction of GST.

Now, this virus again brings further shock for the Indian economy. Small and medium sized enterprises. unorganized sectors and agricultural sector that constitute the biggest employment source of all workforces in the country are being badly affected. But these labour-intensive sectors have fallen out of favour of the government and all the relief packages of the government during economic recession has been gifted to the big corporations. Some labourintensive sector is already denying wage to their workers. If major workforce of the country goes penniless, no magic can inspire demand in the market. Thus, the perilous cycle (withering income, withering demand, withering employment, further withering income, then further withering demand) is setting on, taking Indian economy further deep into the trouble. There are so many reasons to fear that such situation may provide excuse for employers to justify not only wage cut but also large scale closure, mass retrenchment and all other forms of victimization. In absence of government's intervention, the cascading effect, may very much lead to severe acute livelihood destruction (SALD) among the entire population in this country.

The virus outbreak has seen rapidly-increased level of state intervention (government's intervention) across the world. The Spanish government has nationalized all of its hospitals and private healthcare facilities before the virus infected ten thousand citizens. Making success of lockdown measures China ensured doorstep delivery of the essentials. Not just socialist countries, all governments across the world, including the industrialized nations, taking responsibility of citizens' healthcare and their daily necessities. Surprising as it may appear, the buck advocates naked of privatization, the International Monetary Fund, in its blog. now recommends 'increased role for the public sector' (Giovanni and others, IMF blog, 01.04.2020). The idea of 'welfare state' makes a quick comeback across the globe. Keeping the poor and vulnerable safe is a matter of responsibility for the state and the private sector, not an act of charity' writes Christophe Jaffrelot and Utsay Shah (Indian Express. March 30, 2020). But, none of the intervention of the central government has brought smile in the faces of the poor common people. All the recent speeches of the respectable PM provided no assertion on the onerous issues of the food insecurity of the citizens. In his last speech, he advised citizens to take care of fellow citizens ('take as much care of poor families as you can, especially try to fulfill their food requirements'). Further to this, recently, the central government has decided that ethanol will be produced from 'excess' rice presently (which is produced from sugarcane) to meet the high demand of hand sanitizer. It has further multiplied the fear of food insecurity.

This is an extraordinary time and individual citizen along with fellow citizen cannot fight such a situation. Now, it is essential that the 'vital functions of the welfare state' should return. Rural and urban poor must be supported by the government, healthcare should be available universally through public facilities, livelihood of all has to be ensured by the government and daily necessities and food must be available through universal and efficient public distribution system.

Working people throughout the country are restless, so are the field workers. But restlessness may be obvious but offers no remedy. Keeping physical and mental health is the need of the hour. Field workers movement and the entire working class movement in this country in general needs healthy people who hope for the best but are prepared for the worst.

PM Narendra Modi in his lecture (16th October, 2014) stated that the phrase 'Shramev Jayate' had as much significance as **Satvamev** Jayate' "(narendramodi.in). 'Satyamev Jayate nanritam' is quoted from a text in the Mundaka Upanishad that means 'truth only triumphs not falsehood'. Similarly the phrase, Shramev Jayate, means 'labour only triumphs'. We concur with our PM in this matter. Yes, labour will triumph in the final count.

# FMRAI Mysuru GCM resolution On sales related harassment and newer form of attacks

The General Council Meeting of FMRAI held at Mysore from 14th to 16th February, 2020 notes that the active push for neo-liberal economic policies adopted by the government had adverse effect.

During the past we have experienced the radical change in Industrial approach towards their workers. Now pro employer Government's policies are encouraging the employers to deprive their workers of their rights and of the laws and bilateral agreements, selling / shifting of established brands and thereby declaring closure or retrenching the sales promotion employees subsequent to declaring the company / division non-viable. Management is trying to break all agreed work norms through electronic reporting / detailing through newer electronic gazettes and software to monitor the activity of the SPEs. Hence, unilateral change of the existing work

#### This GCM Demands:

- 1. To ensure application of the principles of natural justice for the Sales Promotion Employees.
- 2. There should not be any unilateral change in working conditions without following the law.
- 3. Bilateral agreement on working and Service Conditions of the SPEs.
- 4. That use of any sort of technological advancement should be within the purview of law and it should not cause any hardship and increase in workload.
- 5. No disciplinary action through the electronic system including stoppage or deduction of wages & expenses.
- 6. No locking of portal of the Sales Promotion Employees to submit their daily work reports.
- 7. That the employer must be held responsible for cyber-security as per law to ensure protection of password and to stop cyber-crime against the Sales Promotion Employees.

The Industry is moving ahead with their policy of restructuring the marketing system through rapid replacement of unionized section through recruitment of the sales officer categories in non bargainable category in gross violation of Sales Promotion Employees (Condition of Services) Act 1976 and in violation of Contract Labour (Regulation and Abolition), which was further advanced with the introduction of newer divisions or mergers and acquisitions. The employers are rampantly violating laws and depriving the SPEs from their right of annual increment, making sales an integral part of service conditions and victimizing on the ground of Sales, imposing new work systems in violation

implementations of programmes throughout the country across state and sub units of the organization. He also dealt upon various impending organizational tasks including strengthening the organizational structure up to the norms has become the most common phenomena of the industry.

The conventional form of reporting is replaced by either web reporting or mobile reporting. Detailing through visual aid has also moved to online digital media. Employers are using the advantages of technology to exploit the workers and more so to control their work. One of the major problems related to electronic system of reporting is "locking of portal" to impose newer work system, to impose illegal lockout, wage deductions, disciplinary actions etc. Apart from locking, employers are also insisting for call to call reporting. In the new situation the server is in the control of the management and tampering of records is possible and we have many such incidents. Managements are even

subunit level, increasing membership etc. Joint movement along with CITU and other like-minded fratemal trade unions to combat the government policies is the need of the hour, emphasized he.

Jamini Barbaruah, President of CRU (NER) in his concluding speech complimented the misusing the advantage of the new technology to deny the legal rights of the SPEs, such as to participate and report "Strike". These are glaring instances of violation of the laws to deny the rights of the workers using the new form of technology.

The conventional types of visual aid and literatures are being replaced by I-Pad, Tabs, etc. and using GPS and its applications and the detailing becomes online. Further this

marketing and promotional activities, and managerial support. If all these activities sail in a systemic process, then sale is the consequence of that process.

Therefore, making the SPE's solely responsible for the SALE and awarding punishment is grossly unlawful. There are many unfortunate and tragic consequences of these humiliations as in Micro, Indoco, Zydus, Wanbury, etc. Job loss is the key issue now

- Continue to oppose such activities of the employers through our organizational strength and also explore the legal avenues for relief.
- 2. To campaign these issues among doctors, chemists and others seeking their support.
- Stand beside the field worker in all possible manner legally and agitationally facing Job Loss due to closure.
- 4. To generate a powerful movement against the misuse of technology by mobilizing the fieldworkers to oppose newer forms of attacks and to resist harassment of the workers.

online detailing gets recorded and can be accessed by the company any time. Thus, intrusion in the privacy and dignity of the individual, surveillance etc. are being done by the managements. All these methods give immense scope to the employers to harass the employees on many counts.

This General Council meeting condemns these anti worker activities of the management and register strong opposition against the abuse of science and technology in the name of digital advancement.

The GCM also noted that the Industry is trying to impose the responsibility of sales exclusively on the SPE's and pursuing the concept of "sales as a part of service condition". It is well established fact that systematic activities are the outcome of the co-operation between employer and employee. Hence, it is implied that the sales is not the exclusive responsibility of the SPE's. Sales are based on some process including individual inputs complemented with product promotional strategy,

members of the Imphal district of CRU for successfully hosting the conference by exhibiting gumption and their sincere attachment to the organization. Singhajit Singh, Secretary of the Reception Committee thanked all General Council Members for their co-operation. In all 122 General Council Members in our industry, due to closure of divisions and selling of brands. Glenmark Gynae division sold to a company called True North. Recently GSK announced closure of Respicare division and retrenched more than 150 SPE's, MSD transferred few field workers after selling the division to Abbott and more than 100 fieldworkers were retrenched, Abbott transferred major brands of Respicare to other divisions and retrenched more than 50 fieldworkers and transferred 50 to other divisions and around 30 are protected due to our intervention. Platinex division of Zydus - Biochem has been closed down on the plea of low output and few of the SPEs are accommodated in other divisions and few are with no fieldwork but are assured of wages. Latest is Wockhardt selling out major brands to DRL with a declaration that employment will be protected. Many more such happened in the past and will also be continuing. In these entire cases field workers are facing Job Loss or getting victimize in various manner.

including 33% reservation in Parliament including the demand of withdrawal of CAA and boycott of NPR and NRC linking it with the question of women's legal rights. The Central Budget 2020-21 has also totally neglected the issues of workers in general and women workers in particular. It is estimated by UN that over 51% of work done by women in India is unpaid and not counted in national statistics and as per ILO, women's unpaid work, especially care work subsidizes the cost of care and support economies. It is estimated that women's wages are 34% less than that of men doing the same job in rural areas, and 19% less in urban areas in our country. India has the highest gap. gender wage Overwhelming majority of women workers, particularly in the unorganized sector, where they are concentrated, do not get maternity benefits and crèche facilities.

In view of this, General Council Meeting of FMRAI at Mysuru gave call to advance the struggle for women's equality in all respects and against social oppression and called upon for 'Women's Jail Bharo' on 6th March, 2020 jointly with AICCWW (CITU) and AIDWA on the occasion of International Women's Day and to organize hall meetings / conventions on 8th March, 2020

The 20th General Council Meeting of CRU (NER) was held in Gandhi memorial hall, Imphal, Manipur on 6th and 7th March, 2020. Since the inception CRU forty seven years back, this is the first time when Imphal district (the capital city of Imphal is an organizational district of CRU) were hosts to the General Council Meeting.
