All confirmed PSR's will be covered under this settlement. The settlement is effective for a The Negotiating committee elected in the All India Council meeting of FMRAI was represented by Kaushik Sarkar, All India Convener, E.V. Rajesh, Joint All India Convener, Sanjay Chakraborty, (Joint Zonal Convener East), Anil Bhatnagar, (Zonal Convener North), Hitesh Parekh (Zonal Convener West) and P.C. Thomas (Zonal Convener South). The average benefit in the wage part is Rs. 6303 with

The existing system of payment of House rent allowance @ Rs.10% per month shall continue. The special pay revised as per length of service is 0 to 15 years of service of Rs. 2885 per month and above 15 years of service of Rs.3360 and for above 25 years of service of Rs. 3410. A robust new year arrives. In the 2nd fortnight of the first month, on19th January, 2022, the field workers will go on

strike. -'Why organize a strike now? Haven't the farmers gone home back ?' On hearing this news, the neighbour asks.

-'Yes, that's the point, their examples are hugely inspiring. The field workers have only picked up the threads!'

-'But, a third wave is imminent with all these Omicron, Delta and all the damning viruses!' The neighbour is utterly disturbed. The daring variants of the unyielding virus, now, masquerade as Greek alphabet. His disquiet is evident and discernible in his face.

-'The strike is even more relevant in view of the pandemic', replies the field worker.

In fact, this strike of the field workers raises the demands of their neibourhood, besides their own demands. Reduce medicine prices; reduce prices of the medical devices! Government must earmark and spend enough funds for healthcare need of the common people, demands the 19th January strike of the field workers. Can common people pay for hugely expensive private healthcare? No, they can't pay. The pandemic has withered their spending power. Demands of universal healthcare and universal access to essential medicines. has never been as relevant, as it is today. Why then the governments are indifferent? Why the employers are mounting attacks upon the field workers? Why the government stands as mute spectator, or even as whispering collaborators, of the As employers? the Governments the and employers choose such role, field workers choose their ultimate, and inevitable, instrument of protest: strike! The government should ensure that indispensible lives are not lost on account of dearth of hospital beds, of oxygen, of ambulance or of medicines. The 2nd wave has witnessed all

following ranges, Range I: year 0 to year 10- Rs. 10000 to Rs. 16289. Range II: above 10 years- Rs. 18084 to open end. The existing annual increments will continue to be 5% till 10 years and 4.6% thereafter based on the year of service of the PSR. The Special Allowance will continue to be 25% of basic pay. Reasonable additional sum will automatically be accrued due to upward revision of basic pay. The SA will also attract all terminal benefits. HRA will be calculated as per the existing formula of 30% of basic pay plus special allowance and will automatically increase with upward increase of basic and SA. The city compensatory allowance has been revised from 3500 to 3800 and will cover 21 enlisted cities. The rest of the PSRs of other towns will have increased amount of 2800 over the earlier 2500. The Vehicle Maintenance Allowance has been upwardly revised to Rs. 4500 from existing Rs. 4000. The domicillary medical benefit @ the rate of 8.33% will continue with automatic increased accrued benefits Ø

these. Medicines, including Remdesivir and other anti-viral, have been sold in black market in exorbitant price. Why then government is allowing monopoly (or Oligopoly) of Remdesivir? Even the Supreme Court suggested the government that the patent (monopoly) medicines like Remdesivir and vaccines like Covishield and Covaxin should be freed from monopoly clutch of MNCs by invoking the Compulsory licensing provision of the Patent Act, licensina 1970, and thereby the other efficient manufacturers be allowed to manufacture and sell such products at affordable prices. Suppression of monopoly (patent) and enabling of free competition at this time of virulent outbreak would have brought prices down. But the government in its affidavit submitted to the Supreme Court on 9th May, 2021, the Central Government denied Compulsory License for medicines like Remdesivir and most surprisingly, spoke in the language of the spokespersons of the multinational corporations and advocated for Voluntary License. Unlike Compulsory License at the intervention of the government, Voluntary Licenses are issued by MNCs themselves at their own free will charging go-asyou-like royalty against such licenses. The global licenses. global experience shows that the MNCs defend their position, in the midst of popular outcry for Compulsory License, by issuing a few Voluntary Licenses, without compromising their basic patent monopoly. This position of the government is not acceptable to the people or to the field workers. FMRAI demands revocation of patent on essential medicines and vaccines and had sent several communications to the government to this effect. But, the government attempts to undo all the rights and gains of the common people, which were because of upward revision of the basic and special allowance. The sum of hospital benefit will continue as before. The existing rate of LTA shall continue to be @8.33%. However owing to revised basic and special allowance there will be automatic gain here too. The system of paying bonus and social securities will continue as per existing norms and practice. Daily Allowances has been increased @ Rs. 50 from 1.12.2021 over the

existing ones in all metro and non metro cities on all working days. The average benefit in this head is Rs. 1250 per month in all categories of cities. Out station hotel stay bill limits during attending meetings has been increased from existing Rs. 400 to Rs. 800 w.e.f. 1st December 2021. The same in the RSM headquarters will be Rs. 1000 from earlier Rs. 800, and in the DYSM headquarters it will be Rs. 1200 from Bs. 1000. Travel fares has been increased to Rs.4.00 from 3.50 per kilometre. Apart from this, with every Rs. 5 hike in petrol prices in Delhi city there will be an increase of Rs. 0.15rise in the km fare in all kinds of approved travel modes. The arrears of the settlement will be paid within 90 days of receiving the accrued through freedom struggle and which were attained in post-independence India. A report of the parliamentary standing committee (laid on the Table of Lok Sabha and Rajya Sabha on 23rd July, 2021) advocates for more rigorous monopoly in different Intellectual Properties (Patent, Copyright etc) and advises government to make further retrograde changes in the Patents Act, 1970 and Copyright Act, 1957. The committee recommends abolition of some safeguards and exceptions (incorporated in the 2005 amendment of Patents Act, 1970) to facilitate loot by the MNCs. The committee sees (without any evidence and context) 'growing menace of such IP crimes in India' and recommends 'a specific legislation to curb counterfeiting and piracy' and asked the government 'to on-ground ensure implementation of stringent IP legislations'. It proposes removal of all possible barriers in granting of patent. It advocates not only faster approval of patent , but also approval with the involvement and prompting (Patent Prosecution Highway, PPH) of industrialized countries, which are home of the big MNCs. It not only proposes clear amendments of various sections, but also asks the government to review the Section 3(d) of the patent act that keeps safeguard against evergreening of patent monopoly and prevents dishonest continuation of patent right far beyond the stipulated 20 year period . Most surprisingly, the committee, also suggests introduction patent right in plants, seeds, non-living substances occurring in nature mathematical methods and Algorithms which amounts to patenting of anything and everything that exists in nature or that exists in the domain of common ancestral knowledge of the generations of the human signed declarations from the PSRs.

The settlement is signed for a period pf three years dated 1st April 2021 to 31 March 2024 and will cover 576 PSRs in totality. It is to be noted that in the current background of increased attack on the rights of the Sales Promotion Employees by various managements of the pharma industry, this settlement forces the rights and privileges of the field workers working in Win Medicare under the guidance of FMRAI and goes on to prove the ability of our beloved federation to guide the workers in the right path to fight and secure their future in the industry.

Obituary

FMRAI deeply mourns his sad and untimely demise and conveys condolences to the bereaved family. being (these things are not patentable under Indian law or under the laws of the most of the countries in the globe). The Report further proposes 'patent pending' labeling well before approval (to give 'marketing benefits to the patentees? even if these products may later be rejected by the patent controller. The introduction part of the report stated that the report was prepared only in consultation with the industry associations like CII, FICCÍ, some law farms and the Ministries of the Central Government. Even if the recommendations of the committee may have farreaching consequences, no other stake holder was consulted. This report, in fact, attempts to bring back the unbridled multinational domination which was there in the pre-independence India and it is essentially anti-people.

These are very technical issues which common people are not generally aware of. But, it influences the health related outcome and such actions and decisions of the government and the parliament gravely damages the lives of the people.

people. While campaigning with the strike demands the field workers' movement raises these serious issues and makes people aware of. People are dying of diseases, not only the virus, but also of dengue. malaria, tuberculosis. Resistant tuberculosis has reached a menacing proportion and the government has declared tuberculosis a 'national emergency' (by Health Minister Harsh Vardhan on 06.09.2014). Why then the government does not issue compulsory licenses on drugs like Bedaquiline and Delamanid (the only efficient medicine for drug-resistant tuberculosis which is cent percent fatal) to make them available and affordable? Why then the organizations like Jan Swasthya Abhiyan have to file

PIL in the Bombay High Court for free access to such drugs? Whose Atmanirbhar Bharat is this? Why government is raising the issue of patent waiver in WTO and promoting patent monopoly in its own country? Why such double-speak? Should field workers' movement not ask such questions, again and again? Yes, they should.

Therefore, the strike of the field workers is not only the struggle for their own cause, but also for the cause of their neighbours, for the cause of their fellow citizens. At this hour the campaign on the demands of the strike is in full swing. Like the example in the beginning of this write-up, the field workers are engaging with the discussion with their fellow citizens, the doctors, the chemist and the other likeminded persons and organizations.

The employers may appear mighty, but they are not. The rulers may appear colossal, but they are not. Would they have been mighty enough, then they wouldn't have employed allurement, deception and bullying to win the day. If the employers were brave enough, then they wouldn't have barged into the private domain (surveillance) of the workers. If the rulers were open-minded, then they would have sat with the workers' union before making sea-changes in the laws. labour Such secretiveness, for obvious reason, is manifestations of their weakness. Field workers' movement understands this.

One strike may not be enough. Therefore, there will be successive waves of movements and struggle in 2022. 19th January strike attempts to make an early beginning. There will be twodays of working class strike in February, 2022 . In company after company, in sector after sector, struggles of the workers, peasants and the people are gaining momentum. This country cannot be dispatched back to the eighteenth century. Unity of workers and peasants rises here to resist.

Follow the chronology, all the rights and gains will be reclaimed!

18th conference of WBMSRU

like CITU, IMA, Chemist & Druggist Associations and other fraternal trade unions. Strike Committees are being formed for successful implementation of the strike programmes. The 16 point demands are being widely campaigned to the sales promotion industry with serving of Strike Notices to the executives of all companies in the field, company's C&F. stockiest and distributors. Wall writings are in progress in most of the sub units of FMRAI. Posters, banners and flex are being designed by the state units and displayed in various places as a campaign tool. Digital posters are also in the making for virtual campaign and publicity in social media. The news of pre-strike activities is pouring in from all corners of the country. General

Body meetings of DSMRO took place at BTR Bhawan, New Delhi on 21 December, 2021 with the presence of state CITU General Secretary, in 11 sub units of TMSRU, in 19 sub units of BSSRU. Special General Body meetings were held in Bareilly. Shahiahanpur, Haridwar, Mirzapur, Allahabad, Banda, Jhansi, Orai, Bahraich, Varanas, Roorkee, Amroha, Muzaffarnagar, Meerut, Shahganj, Bulandshahr, Sitapur, Lakhimpur, Lucknow, Barabanki, Raebareli, Faizabad, Padrauna, Siddharth Nagar, Deoria, Mau, Fatehpur, Agra, Basti, Aligarh and Azamgarh of UPMSRA where the strike demands were further explained and elaborated amongst the members. Conventions were held in Purba Bardhaman and Murshidabad district of WBMSRU on 16 & 28 December, 2021

respectively. DSMRO distributed 2000 leaflets and 800 posters and TMSRU Printed 5000 handbills and 1100 posters as a campaign material. KSM&SRA have prepared the strike demands in local language in Kannada and to be pasted at all visible places where fieldworkers have access. General Body meetings in all sub unitsare planned. Submission of Strike notices to the managers in the field is going on. HPMRA has organized meetings at Shimla, Solan. Una. Hamirpur. Dharamshala and Mandi and such were held at Moga, Ferozpur and other units of PCMSRU. The fieldworkers are determined to take this campaign to a remarkable magnitude in the coming days and shall leave no stone unturned to make the Strike a historical success.

The study report of competition commission comes short of recommendation

The Competition Commission of India (CCI) an organization engaged in 'market studies to better understand sectors. markets, or business practices' with a view 'to assess competition and competition barriers' to 'complement the Commission's enforcement and advocacy work', has published a study titled 'Market Study On The Pharmaceutical Sector In India' in November, 2021. During the course of its study the commission made public announcement in February, 2021, for 'conducting consultation with stakeholders', seemingly to gain an understanding of the competition dimensions in generic market, with a view to benefit consumers and improve access to affordable healthcare. to which FMRAI responded by sending its observation on these important issues in the form of a letter (vide FMRAI News, April, the 2021). Subsequently, commission invited FMRAI for further discussion and held meeting with FMRAI leadership over virtual platform.

The study exhaustively covers different aspects of generic drugs, branded generics, role of trade associations, trade margins, online pharmacies, drug pricing etc. The issues and recommendations were documented in a policy note. Ninety nine market participants including FMRAI, experts, trade associates, stockiest, doctors, chemists were consulted during the course of the study.

The study observes that Indian spend from their pocket the lion's share of their healthcare expenditure in medicines (a recent study, hyperlinked to this study, shows that sending on medicines constitute nearly 63% of out of pocket healthcare expenditure in 2018). 'Thus, expenditure in 2018). prices of pharmaceuticals have a significant bearing on access to healthcare' and 'competition is expected to be the key source of price discipline for the rest of the market' observes the commission, the commission

further observes that the 'Patented/originator drugs are insulated from competition for the life of the patent' and 'Generic drugs (generics) play an important part in creating the competitive pressures that enable keeping prescription drug prices low, thereby reducing healthcare costs and *improving access'.* The study states that '87% of drugs dispensed in India are socalled branded generics, i.e., generic drugs sold with brand names. The market for "branded generic" is a phenomenon almost unique to India'. What the study does not state that there was no distinction between 'brands' and 'branded generics' in India before the onset of the patent regime (2005) and in spite of presence thousands of brands the free competition existed in Indian pharmaceutical market and existence of brands had never led to monopolization of the market since promulgation of Patent Act 1970. The study, however, admits that huge growth of pharmaceutical manufacturing capacity has been incidental to Patent Act 1970. 'From being a net importer of drugs in the 1970s to becoming one of the major exporters of drugs and vaccines, India now ranks third and thirteenth globally in terms of volume and value, respectively', the study states. value, Notable variations in price were also observed between brands marketed by the same company which were documented in the study. Market leaders in the pharmaceutical sector, even in the presence of a large number of firms and brands, charge prices that are relatively higher than other market participants, especially those with lower market share. The commission further studied such price difference between brands in generic formulation market and found that , one of the top selling formulations in the antibiotic category, namely, amoxicillin + clavulanic acid (Tablet, 125/500 mg), is currently sold by 217

companies under 292 brands. Substantial price variation is observed between companies selling different brands, ranging from Rs. 40 to Rs. 336 for a pack of six tablets. What the commission does not mention in this study is that the transition from cost based pricing mechanism to market-based pricing mechanism, at the instance of the government has entirely diluted the price control mechanism in the country. The study also does not mention the adverse impact of GST on the medicine prices, nor does it mention the essential roles PSUs in making the quality medicines freely available and affordable, the matter which FMRAI is raising vociferously since long.

The study also discusses several other issues including drug distribution, trade margin rationalization, virtues and vices of online pharmacies, alleged relationship between brand entity and quality of drugs etc. The study does not make any mention of unethical marketing practices by the giant pharmaceutical companies which has significant impact on the quality of drugs marketed in the country. The commission, however, urged **'for a** multi-pronged and

a multi-pronged harmonized reg regulatory response to the issue of drug quality' and suggested some measures like uniform and effective implementation of existing quality standards, better transparency, periodic, systematic and scientific testing of drugs, quality control across supply chain, quality control in public procurement etc The study, in totality, gathered many diverse views of different stake holders, made quite a serious academic exercise, but, lamentably enough went short of any firm conclusion or recommendation. Many of the observations of the commission justify and vindicate the views of FMRAI. But, these views of FMRAI, on many onerous issues related to the access to essential medicines, were hardly evident in the mainstay of the study.

AFD releases bonus

Impact of synchronized movement and follow up in three Karnataka-based companies

The synchronized movement organizing Dharna before the head office of three Karnataka-based companies(AFD, British Biologicals and Himalava) with participation of field workers of these companies, along with coordinated programmes before state's labour office at Bengaluru and Dharna before the labour office at district level, like the one which was held at Kalaburgi, all of which were held in November, 2021 with active involvement of KSM& SRA members and at the call of FMRAL has further exposed the vindictive nature, malafide intention and out rightlyunlawful anti-union face of these managements.

These movements have also inspired the field workers which, indeed, have opened a new vista to surge ahead. Following these Dharna and demonstrations, the complaint petitions are being pursued in the labour department of Karnataka. The complaint petitions are raised on violation of SPE Act, Bonus Act, Industrial Employment (Standing Orders) Act and Minimum Wages Act. Further complaints are there for unlawful deduction of wages during the covid-19, unlawful termination in the guise of VRS, unilateral imposition of working conditions, illegal locking of reporting portal and for nonconstitution of grievance redress forum for the field workers of these three companies.

January 2022

The follow up programmes are causing certain movements in the labour department of Karnataka. Now, the erring management of these companies has started wearing some make-up to cover their wrongdoing even if their main intention, of snatching away the trade union, collective bargaining and legal rights of the fieldworkers, has not changed.

However, under the movemental and legal pressure, recently, the management of AFD has communicated to the labour department and has released pending Bonus for the year 2020 – 2021 to those sales promotion employees who were not paid earlier. The struggle for rights in these companies will continue in the days to come.

Despite that, out of mutual consultation and consensus a delegation of three leaders from All India Council was supposed to meet the management at Head Office recently whom management of Wallace refused to meet. Since long Wallace pharmaceutical had been operating through Pharma division but in the last few years the company had launched various other divisions like Rivela, Lifestyle, Lifestyle DC and Gastrova apart from Pharma division and recruited Sales Promotion Employees in various

to settle the charter of demands which is pending for more than three years. Even the mutual agreement which was arrived at the tripartite meeting in front of the labour commissioner of West Bengal has been thrown to the wind by the high-handed attitude of the management. In the above background, on the 30th of December, 2021, the field workers of Albert David resorted to one dav strike to vent out their anger against the management throughout the country. They also staged sit-in dharna in front of company's establishments in all state capitals with remarkable participation and involvement. The day of the strike was preceded by submission of strike notices elucidating the demands of the field worker by the members of the sub unit council sub committees to the executives of the company. Massive mobilisation tasks were also undertaken to prepare the council members of ADL to resort to strike and
