### Countrywide strike in Zydus

The conflict between the management of Zydus and the Sales promotion Employees sees no signs of abatement. The management is continuing to impose unfair labour policies in multiple ways. The unilateral change of working norms through launch of various apps and other digital initiatives, market feedback based sales assessments, etc placed by FMRAI and the same is under legal persuasion. In Biochem Vivo division, since long FMRAI is the recognized union through six successive wage settlements. Instead of settling the 7th Charter of Demands, now management is trying to change the working and service condition of these SPEs. When the COD is pending before

**Editorial** 

### Towards an organization that simultaneously operates in multiple level

harvested by the Indian ruling class since 1991, have nothing liberal it. On the contrary, it has everything illiberal and cruel. With the help of these instruments, the ruling classes, since then, are trying to weaken and bust the trade union movement in the country. The main agenda is corporatedriven 'labour reform' in an IMFsponsored economy. Up to 2014, these labour reforms were executed with all the labour laws keeping intact in place. Recently, this labour reform has become shameless through sea changes in labour laws. Now. the forked tongues of the ruling classes, is more clearly visible than ever. Before 2014, under these reforms, the employers hoodwinked the workers by circumventing, evading and ignoring the existing laws. After 2014, they attempt to blow up the laws, altogether. The attacks of the employers in the form of closure, mass dismissal, mass transfer, de-unionization, decategorization, casualization and contractorization (the worst form of contractualization) are the phenomena that haunted the working class all along this period. Now, they make efforts in enslaving the workers lawfully. Now, they attempt to enslave them with fewer and fewer number of machines and with newer and newer internetand-app-based technologies and keep them under maddening round-the clock supervision. The working class under in India, through all their blood, sweat and tears, is reeling under this most recent and most serious form of aggression of

the Indian aristocracy. At the current time, deep sense of injustice among the minds of the field workers is the most important rallying ground. In the background of merciless exploitation, humiliation, everincreasing workload, rapidlyreducing wage, this old prism through which field workers are asked look at the employeremployee relation does not work. Now, this deception is more exposed than ever. Field workers refuse to look through this obscure glass of the employers and they search for a new vision and a solution.

Such a situation, in the past, necessitated organization and FMRAI came into being. Now, FMRAI stands as the most feasible, and the most visible,

organization of the field workers there in every corner of the country. It gives voice to the field Field workers movement, strives to bring home justice and fights to protect rights of the field workers that translates to the durable gains. Now, the escalation by the employers demands serious opposition. This concrete situation creates need and possibility of mobilization in struggles in the fireplace of which stands FMRAI. In this backdrop the twenty-sixth conference of FMRAI is being held at Kota in Rajasthan between 10th and March, 2022. The agenda of recovering rights and gains and action programmes for occupying new space will become the mainstay of this conference. In the two years of virus epidemic, consequent lockdowns and restrictions, the movements and organization of the field workers has somewhat suffered. Therefore, restoration of previous state of organization and movements is the first thing to do. But, this is not enough. Organization and movement require to be advanced further.

field workers movement is conducting many struggles together at the same The movements like policy level movement, council movement, state related movement or democratic democratic movements are conducted concurrently as these movements are inter-connected and complementary to one another. All these movements continuous and simultaneous mobilization. This situation demands that the organization must be prepared for multi-level operation.

In carrying out all these movements, the friends and allies of the movement are identified by FMRAI and they are rallied, to the extent possible, besides mobilizing the members. Exposition of the falsehood of the opponent among the rank of the field workers, before and during the struggle, is extremely necessary as well. Demands of a particular movement or a particular struggle have to be explained to the members with clarity linking it to the day to day experience of the field workers. Agitation and campaign has to be carried out side by side

In company-wise struggle, the realm of council movement, hundreds of field workers are fighting courageously against de-unionization and for recovery of rights. The conference will assess the situation where the employers are imposing wage blockade to frustrate the council movement by cutting off the line. Incidental challenges have to be faced more effectively. In council movement the major task is to generate strong belief and conviction upon the cause of the struggle. This has to be done logically, by explaining both the opportunities and threats. Implementation has to be reviewed with involvement of mass of members, as much a situation permits. Cadres have to be trained, even in the midst of struggle. Adequate number of cadres with due trade-union literacy has to be built. While FMRAI has huge opportunity for heightening and broadening the movements, it has huge

challenges too.
FMRAI assesses relative strength of both sides in every struggle. In weakness and strength, the strategies for the struggles cannot be the same. Strategies change with situation. FMRAI adopts tactics in view of existing reality. This is done for the purpose of drawing further strength and scoring victory. Identification of cleave and fissure in the adversary camp is a worthy strategy as it allows the opportunity for striking it at the weakest point (which may be economic, circumstantial or any other). FMRAI as an organization has adopted the current tactics in the light of current situation only through the due process of review and discussion.

In leading movement to success, in campaign and mobilization, organization is the most important instrument. But, will it be sharpened further? And how to realize this task? FMRAI documents of the past replies to this question, emphatically: ensure democratic functioning of the organization and remember that democratic functioning 'is a class concept' ('updated Agenda of Action, 2010'). class concept' Democratic functioning is the path which has made FMRAI bigger, stronger and enabled it to spread over time and the entire space the country. This concept'

But, democratic functioning is not confined merely in electing committees or making mutual consultation. These are parts, not all. Mainstay of democratic functioning is the task of ensuring spontaneous involvement, not only by attendance alone but also by participation, of members Without mobilization of members the talks of members the talks of 'democratic functioning' becomes a scholarly exercise. 'Democratic functioning requires 'live contact' and popular consent of all sections of field workers ('agreement of workers') on every matter of importance.

With a view to make mocratic functioning 'democratic **FMRAI** realizable. organization is always kept open for all section of field worker across political belief. A section of field workers may not see through the politics of the ruling classes, while another section may be able to see through. Both these sections understand working class politics and thereby get awakened' only participating, and by gaining through experience, struggle against injustice in the respective areas of struggles. Along this correct path FMRAI is ever built as an organization of mass of field workers. Thus, FMRAI proudly preserves its 'mass character'. conference will attempt to further strengthen this position.

There are many elements to learn from the big struggle of the farmers. Undaunted fighting spirit, ability to make sacrifice for the cause, ability of organizing resourceful mass mobilization are some elements that can be assorted from the long list. The ruling elites wanted to label it as a political mobilization and wanted to dismiss it as a political conspiracy which they did not succeed. The farmers' succeed. The fa movement nipped campaign in the bud as they did not allow the movement to be dyed in any political hue. But, the farmers did not make mistake in identifying the ruling party as the root of their distress. They even went to the extent of organizing electoral campaign against the ruling party at centre. But, all along they maintained their mass character every political colour and shade. This position of nonregimentation enabled the struggle inexhaustible resources for mobilization, gave power to conduct such an enormous struggle for such a long period and, most notably, defeated the purpose of the unscrupulous FMRAI draws rulers. appropriate lessens from this

struggle.

Another most notable character of the farmers movement was its ability to conduct struggle even by making sacrifices of lives and by paying high prices. They rejected the short-cut path of unsolicited compromise which would have led to frustration among the farmers. The history of FMRAI, which is full of momentous struggles and selfless sacrifice of life and lives of many of the field workers, thus concur with the very struggling spirit of amazing struggle of the farmers. This conference will solemnly salute the martyrs of the field workers' movement, not only by paying ceremonious tribute to the martyrs, but also by invoking the very spirit of their struggle and sacrifice. Many of the field workers in the struggles conducted by FMRAI are already making such sacrifices which this conference will earnestly recognize.

FMRAI does not conduct struggle for struggle's sake. Reaching the victorious end is lofty objective. conference attempts to achieve this end by taking organization and movement to the newer and

newer height.

price rise and of cancellation of NPS and restoration of old pension scheme. In addition to all these demands, the Declaration adopted at the national convention of workers also reiterated the demands that are continuously being raised by the joint trade union movement since more than a decade. Taking advantage of law and order situation during pandemic restrictions, management of Albert situation David desperately tried to dismantle the unity of the field workers. The ploy of the management is to deprive the sales promotion employees from their legitimate rights. The sales promotion employees are fighting both legally and agitationally in a befitting manner. Consecutively on 22<sup>nd</sup>, 23<sup>rd</sup>& 24<sup>th</sup> February, 2022 the sales promotion employees resorted to all India Strike and staged Dharna in front of company's head office in Kolkata as a part of ongoing movement, which was attended by one hundred and ninety sales promotion employees from all across the country. The other sales promotion employees who couldnot travel to Kolkata due to constraints observed the strike at their headquarters. The entrance point of Gillander House was decorated with flags, festoons and banners. The striking workers raised slogans at regular intervals and exhibited true fighting spirit. Demonstrations were organised on all the three days in a valiant manner. The gate meeting was addressed by Anadi Sahoo, General Secretary of State CITU on

second day and Subhas Mukherjee, President, CITU West Bengal on the concluding day. The dharna of the striking fieldworkers was greeted by General Secretary FMRAI, Santanu Chatterjee, President Ramesh Sundar, Treasurer Partha Rakshit, Secretariat members Pranab Ray, Arpita MitraRaoy, Sanjay Sen Shubrangshu Bhattacharya and other working committee members of FMRAI. The leaders and members of all India Council of Albert David gave deliberation and vented out their pain and anger against the atrocities of the management. General Secretary of WBMSRU Com. Basab Roychowdhury and all state leadership stood beside the sales promotion employees of Albert David and addressed the gathering during the strike days. The management of Albert David left no stone unturned to foil the militant spirit of the fieldworkers. A meeting was arranged at the office of the Labour Minister. Government of West Bengal at the instance of the management on 22<sup>nd</sup> February, 2022, the first day of the strike where FMRAI attended and explained the justified reasons for strike. But despite instruction of the labour authority to the management to discuss and settle the issues and grievances of the sales promotion employees at bipartite level, the outcome of the meeting was futile due to adamant stance of Albert David management. The three days strike is a historic success and has paved the way for intensification of struggle in the days to come against the onslaught of unfair labour practices of the company with more vigour and strength.

Prior to this, with an alibi of strategic business decision and non-viability, the Zydus management had retrenched a sizeable number of the field workers of PLATINEX division and closed down business operation. In spite of serious persuasion from FMRAI, the management did not absorb these field workers in other operative divisions of the company where vacancies existed. Earlier to this CND division was also withdrawn in January, 2019 which adversely impacted the working and service conditions of the Sales Promotion Employees or even resulted in loss of jobs.

### CRU (NER) Conference at Nalbari, Assam

24th Central Conference of CRU (NER) was held in Nalbari, Assam from 11th to 13th February, 2022.
