11th wage settlement in Stadmed

11th wage settlement was signed successfully between STADMED management and FMRAI for 3 years on 18th April 2022 for the

VDA. TA was revised to Rupees 3.00 and 3.35 per Kilometre for 2nd year and 3rd year, head quarter allowances was increased by



period of 1st April 2020 to 31st March 2023. In the first year of the settlement period the pandemic had disrupted normalcy, in this background a separate pay scale was agreed the first year 2020-2021 with nominal increase and then second pay scale for next two years 2021-2023 with reasonable hike. The basic pay, FDA, VDA, HRA and non-wage components, were revised upwardly. Minimum total benefit derived from the settlement is 4000/-approximately in second year onwards and maximum benefit approximately 11000/-. Basic pay was revised substantially in 2 grades from 0 to 15 years of service and above. Existing VDA was merged in FDA and revised additionally by 260/- and 535/- for 1st and 2nd grade, VDA was revised from Rupees 3.60 to 4.25 per point; HRA was revised from 18 to 19.5% of BASIC, FDA and

Rupees 20.00 and 35.00 for 2nd and 3rd year and accordingly ex-headquarters, outstation and hill station, capital city allowances were also increased. As decided and agreed, the arrear will be paid in 6 equal installments. On behalf of management Ashish Roy (Director), Amit Ray (Finance Director) and Alok Bose Sr. Manager (Admin., Personal & Legal) and from FMRAI, General Secretary Santanu Chatterjee signed the settlement along with committee members J. S. Naruka, Aniruddh Mohapatra, Viresh Pandey, Partho Sinha, A. J. Bhattacharya and Jayanta Chatterjee. The management expressed that sales promotion employees should wholeheartedly cooperate for the growth and prosperity of the company in the future days by executing the agreed parameters of work system.

FMRAI's new office building at New Delhi



A long cherished desire of the members of FMRAI was fulfilled on 27th April, 2022 with the inking of a purchase deal of a property of the organisation at centrally located point of Delhi. The office address is Flat No. 2, First Floor, 4581/15, Daryaganj, New Delhi-110002 (Near Happy School). Prior to purchase, on 25th April, 2022 available FMRAI Secretariat Members visited the premises and unanimously opined

for owning the premises. This new address in the capital of India will be fully utilised for follow up with the central government on policy related matters and also serve as an outpost for strengthening the functioning of FMRAI in the whole of the north zone of the country and specifically in Delhi. A formal inauguration of the premises will be notified shortly after completing necessary furnishing.

14th wage settlement in Solvay legacy currently in Abbott India Limited

The 4th long term service settlement was signed between the management of Abbott India Limited (AIL) and Central amount of Rs. 195/- added at the entry point and Rs 2150/- added at the 36th year. The Fixed Dearness Allowance (FDA) has



Coordination Committee (CCC) representing FMRAI members at the company's head-office in Mumbai. Earlier several mergers and acquisitions resulted in job Medical of transfers Representatives from Duphar-Interfran Limited to Solvay Pharma India Limited and from Solvay Pharma India Limited to Abbott India Limited. In totality this was the 14th consecutive wage settlement for these section of sales promotion employees. This settlement resulted in an average monthly increase of Rs 7500/- per medical representatives out of this 56% went in wages and 44% would contribute in the non-wage part of the settled benefits. The settlement is in effect for 36 months, from 1st January 2020 to 31st December 2022. The minimum monthly benefit is Rs. 3708/- and the maximum benefit Rs. 17327/- as per the length of service. The basic pay scale has been raised from Rs 1300/- to Rs 1550/- at the entry level, and from Rs 34435/- to Rs 42135/- at the 36th year of service. Every three years, the scale is revised upward, with an additional been increased by Rs. 375/- at the entry level and Rs. 1100 at the highest slab. Similarly, the Special Dearness Allowance was revised, with a minimum of Rs. 100/- and a maximum of Rs. 675/- per head per month. Special Pay was increased, with a monthly minimum of Rs. 115/- and a maximum of Rs. 695/- per head. With effect from January 2020, all three existing Variable Dearness Allowance (VDA) slabs, depending upon the service seniority, have been revised upward by an additional amount of Rs. 7.00, Rs. 7.27, and Rs. 8.02, respectively, over and above the 1934 series base index (1934=100). With an increase in basic pay, the house rent allowance (HRA) will rise proportionately, since HRA calculates to 40% of basic pay. In the case of Education Allowance, a minimum of Rs. 100/-and a maximum of Rs. 825/- per month were added for each medical representative depending upon their service seniority. The leave travel concession (LTC) was increased by a minimum of Rs. 800/- and a maximum of Rs. 3000/- per head per annum. The existing

Ex-Gratia amount of Rs. 26,500/has been revised to Rs. 34.500/-The existing amounts for kit allowance, storage allowance, field allowance, and medical allowance have also been increased. The daily allowance has been revised to Rs. 285/- for metro cities and Rs. 270/- for non-metro cities. Daily allowances for ex-station, outstation, hill station, and attendance at company meetings have been increased, including holidays and Sundays if spent in outstations or hill stations. The other terms and conditions of the service settlement remain unchanged. Shantaprasad Nagarmath, Commercial Director-GenNext; Sachin Amdekar, Director-Business HR; Ashok Saini, Associate Director; Pradeep Bidlan, Senior Manager-HR; Rajendra Malik, Sales Manager; and Ansuman Aich, Sales Manager signed the agreement on behalf of the management. Pradip Mazumder, Rajiv Thyagarajan, Mahesh Jakhar, K. V. Ramdev, and Pala Rajesh Kumar signed on behalf of Central Coordination Committee (CCC) representing FMRAI.

Wage settlement signed in Zydus FMRAI greets erstwhile Vivo fieldworkers

The management of Zydus Healthcare signed the 7th wage settlement with FMRAI's negotiating Committee on the longnegotiating Committee on the long-pending Charter of demands for the erstwhile Vivo (Biochem) division fieldworkers on April 21st, 2022. The settlement will be applicable for 3 years from 1st April 2018 till 31st March, 2021. The average monthly increase of salary and allowances works out to Rs. 4500/-. FMRAI had submitted the Charter of demands in the beginning of 2018, after the expiry of the previous settlement on March 31, 2018. Several rounds of negotiations were held bilaterally. However, the management placed counter demands on the work procedures, which was not acceptable. Thereafter, the management started their deunionization activities by allurement of the MRs as TBMs and started transferring and terminating fieldworkers who resisted such moves of the management. The negotiations came to a literal standstill. FMRAI launched countrywide movement against such attacks and the delay in signing the settlement. In the



meantime, management filed an Unfair Labour Practices (ULP) complaint in the Industrial Court at Mumbai against FMRAI and in turn a ULP review application was filed against the same. A separate ULP complaint on the termination and transfer cases were filed. There were several hearings on the ULPs

at the court. Finally, as per the advice of the Hon'ble court, both the parties conducted discussions from April 18th to 20th at Mumbai and agreements were reached on the MOS and MOU. Two seperate agreements were signed on April 21. Thereafter, management withdrew their ULP complaint and FMRAI withdrew the review application on the said ULP. It was also submitted that both parties will discuss and conclude on the pending victimization issues and inform the outcome to the court within 90 days and thereafter FMRAI's situation of increasing attacks on the jobs, working conditions of the SPEs and de-unionization attempts of the managements in the industry. FMRAI greets the Zydus Biochem fieldworkers for their determination and consistent struggle under the banner of FMRAI and for reinforcing their collective bargaining rights and thereby advancing our council movement.

Editorial

Statutory UCPMP: A step ahead

FMRAI is pursuing several demands with the central government which has got direct bearing on the health and related matters of the people of this country. Demands for a rational drug policy, judicious usage of drugs, easy and rational access of medicines to the people, reduction of medicine prices, allocation of 5% of GDP for healthcare etc. have been the mainstay of the demands since the inception of the federation. In recent times, the demand for zero GST on essential medicines, revival of public sector pharma and vaccine plants have also been highlighted.

In addition to these, the unethical practices adopted by the employers of the pharma industry for rapid increase of their business have been continuously brought to the notice of the Central Government. FMRAI leadership met the Minister of Chemicals and Fertilizers on several occasions and the sub units submitted memorandum with a demand to curb such unethical practices. Other like minded organisations and individuals have lend support to the issue. Even National Medical Council, Indian Medical Association and other related organisations have raised concerns over such unethical practices of Pharmaceutical industry being allowed to operate at the behest of the employers. The necessity to curb the widespread unethical approach of the pharma industry to fetch business was accepted government too and in the year 2015, the central government framed a Uniform Code for Pharmaceutical Marketing Practices (UCPMP), a voluntary Marketing code to be monitored by the industry associations. Such voluntary code was of no use to curb the prevailing unethical practices in the pharma industry. In fact industry associations have never acted upon despite reporting several unethical practices. In the year 2016-2017 Government of India called official stake holders meetings thrice, under Ministry of Chemicals and

pharmaceuticals in relation to UCPMP. In the said meetings FMRAI exposed the corrupt practices by the pharmaceutical industry and sufficient evidences were placed before the government. In the draft pharmaceutical policy of 2017 released by the Department of Pharmaceuticals, it was stated,While The Drugs & Magic Act prohibits any advertisement of a drug, such 'educational' drug, such 'educational' conferences are used to circumvent and play the trick. These add to the overhead cost of the drugs. It is assuming menacing proportions and needs to be addressed through the new pharmaceutical policy." The Central Government realising the fact that voluntary code is insufficient to control unethical marketing practices, decided in the vear 2018 to make UCPMF mandatory, which is mentioned in the 2017-18 annual report of the Department of Pharmaceuticals. Due to strong lobbying by the pharmaceutical industry, proposal to make UCPMP mandatory is kept in cold storage by the central government.

In spite of accepting the above in black and white and despite wide spread reports of the government's inaction on the unethical marketing practices adopted by various pharma companies, the government is clearly non committal on the issue of bringing teeth in the said code by framing a law with the provision of punishment for the erring companies. While the PM goes on record abroad by citing examples of "foreign trips" and other benefits meted out to the doctors, his government has been hiding under the shadow of silence on the issue in India only to please the corporates who are the sole source of unfair practices.

The DoP secretary held a meeting on 23 December, 2019 to review the implementation of UCPMP which is being voluntarily adopted by the pharmaceutical companies since 2015. The codes voluntary period had already expired in June 2015, yet the Government has not initiated any action on its part by making it a statute and adding penal measures for violation.
The Department of pharmac

euticals (DoP) has also admitted in Parliament that under the UCPMP, there is no provision for it to directly deal with complaints received regarding unethical practices by pharma companies. An exercise is underway to make pharma associations submit quarterly reports to drug price regulator. In response to a question in the Parliament The DOP said "As per UCPMP, any complaint received against a pharmaceutical company is to be handled by an Ethical Committee for Pharma Marketing Practices, that is, to be constituted in each of the pharmaceutical associations. DoP has been following up with pharma associations to implement the code effectively. This department has also taken multiple meetings with associations, most of whom have put UCPMP on their websites and constituted committees for handling complaints regarding breach of UCPMP." The above confirms the demand of FMRAI that until statutory provisions are incorporated in the code, it is a useless instrument to curb unethical practices in pharma marketing.

A recent study by SATHI (Support for Advocacy and Training to Health Initiatives), claimed that promotional practices of the pharmaceutical industry and implementation of status of related regulatory codes in India lacked credibility". It revealed that pharma companies widely used various unethical means to ensure business. There are reports which say that the unethical means adopted by the pharmaceutical companies have also strained the professional relationship of the Medical representatives and the Doctors whom they visit. In spite of the Department of Pharmaceuticals repeatedly asking the pharma industry to initiate and step up self regulations, nothing has happened and the nexus at the the doctors and the Representatives into the vicious network continues unabated, making them scapegoat because of the very nature of their profession,

The voluntary code of ethical promotional will have no bearing on an industry which for ages has adopted these unethical methods to further their business interests. Today it is absurd and ridiculous to see that still the DoP is in the mode of "reprimanding the unruly child for course correction". Until the necessary punishment clause is brought out within the framework of a law, the industry will simply not bother to follow any of the so called

voluntary guidelines. In this back ground FMRAI decided to file Public interest litigation before the Supreme Court to make UCPMP statutory and accordingly senior advocate Sanjay Parikh, filed the petition on behalf of the union. The said writ petition 323 of 2021 is filed with a prayer to make the UCPMP effective by providing a monitoring mechanism, accountability transparency, and consequences of violations and providing it a statutory basis. Further till an effective law is enacted Hon'ble Court may lay down the guidelines, which should be followed by all the authorities/ courts under Árticles 32, 141, 142 and 144 of the Constitution. The said Writ petition 323 of 2021

was heard by the Hon ble DR. Justice D.Y.Chandrachud and Justice Surya Kant on 13th March 2022. An order was passed for issuing a notice to the Central Government to file their response within a period of 6 weeks, which was further been extended and will be heard after the summer vacation.

The standpoint of FMRAI vis a vis the unethical practises adopted by the pharma companies and the compulsion for going to the Apex court, is only to protect the ailing people from financial exploitation as the expenditure incurred on such corrupt practices is added to the cost of medicines by the employers, which needs wide campaign amongst the masses.

Trade union strategic planning workshop by ILO

A Trade Union strategic planning workshop of ILO, took place at Indian Habitat centre, New Delhi for three days from 19th -20thApril, and a follow up meeting was conducted on 25th April. The welcome address was given by Walter Dagmar, Director ILO, DWT and CO India. The introduction of the programme was laid, the topics and methodology discussed, with a view to get some expected outputs. An introductory remarks and expectation were also laid by the leaders.

The first session was on the impact of Covid on the working class and ILO response for human centre recovery and trade union management. The second session was on impact of Covid on Indian workers and trade union response, expectations and challenges during the pandemic. A sustainable and inclusive way for recovery was also discussed.

Day 2 started with the agenda of protecting workers promoting fundamentals and right to work and strengthening tripartism. The new labour codes and rules therein were discussed. Later drafting a resolution for the ratification of ILO was done in the plenary session. The topic of discussion next was the future of work opportunities and challenges of trade unions. It was identified that the future strength lies in the new form of work force e.g., the gig workers, the care givers, the IT workers etc. and challenges lie in protecting the vulnerable workers and climate changes. An initiative was taken to develop a work plan for 22-23, to consolidate the output and forming a technical team to finalise the strategies and work plan. The workshop on t on 25th April took place in ILO office. A follow up meeting was done with CTUs ILO focal persons and other project officials. The issues were prioritized, and the meeting ended with the closing remarks from the chairperson.

Protest action in TTK by the sales promotion employees

The field workers of TTK have demonstrated their fighting spirit in the midst of serious confusion and apprehension due to sell of the Human Pharma division to BSV Pharma Private Limited and Miransa Limited. In this serious development, FMRAI has placed the demand to the management to call urgent Welfare Committee meeting to resolve all the concerns of the field workers through an amicable discussion. The plan sell off was not intimated by this management to the committee members during the negotiating committee meeting which took place on the same day. FMRAI is demanding smooth transfer and protection of jobs as well as to maintain the service and working conditions, settlement of the pending COD to the management.

Memorandum submission programme has been successfully implemented by the field workers of TTK in majority of the places across the country during the company budget meeting between 8th to 23rd of April, 2022. In North zone memorandum submission took placed in Jammu, Chandigarh, Ghaziabad, Lucknow and Jaipur of Rajasthan. Similarly in West zone field workers of TTK has submitted the memorandum in Nagpur, Mumbai, Pune, Indore and in Raipur. In South zone it has been observed that council members placed the demands by submitting memorandum in Ernakulam, Munnar, Hubli, Bangalore, Vizag, Madurai and in Chennai city. Same programme took placed in Kolkata, Patna, Siliguri, Guwahati and Puri

Mass retrenchment in Novartis

M/s Novartis India has summarily terminated more than 300 sales promotion employees of the company on 11th February 2022 through the issuance of just an email. This inhuman treatment of the management towards their sales promotion employees is absolutely unfair, illegal and in contravention to the laws of the land. Such step of summary dismissal emerged out of an exclusive sales and distribution agreement with M/S Dr. Reddy's Laboratories Ltd, and through the deal that marketing rights of the products of

EMD division had been shifted to Dr. Reddy's Laboratories. These products of the division were established by the relentless effort and hard labour of the retrenched sales promotion employees of Novartis. This unfair act of the management has thrown hundreds of sales promotion employees in the grab of unemployment in today's scenario. FMRAI has sent a letter to the management of Novartis demanding gainful employment with continuity of service benefits, full back wages and other consequential benefits.
